The defendants were each convicted of unlawful drug possession charges and now seek to set aside the verdicts, arguing that they were denied a fair trial by the prosecutor's repeated personal attacks on the defendants' character. The defendants also claim that they were denied a fair trial because they were erroneously prevented from presenting evidence of their good character. The defendants' claims are not persuasive. Under well established principles of Maryland law, "evidence of good character ordinarily is admissible where the accused rests without putting his character in issue." *State v. Faulkner*, 267 Md. 277, 293, 297 A.2d 678, 685 (1972). Once the defendant takes the stand, as he did in this case, however, the same policy considerations that underlie the exception to the hearsay rule often apply to a defendant's good character. *Id.* at 293, 297 A.2d at 684. When the accused takes the stand, the balance of value between the public interest in fair and efficient enforcement of criminal sanctions and the defendant's interest in his reputation must be struck. The potential for prejudice to the defendant becomes too great when the prosecutor is permitted to ask the jury to evaluate the defendant's good character on the basis of testimony that is inherently inflammatory or possesses no permissible evidentiary value. *Id.* at 293, 297 A.2d at 685. In this case, the prosecutor's questions to the defendants at trial were rooted in his theory of the case -- that the defendants had stolen and sold drugs at the present time. They were not suggested to show that the defendants were guilty of crimes other than the ones that were charged. Because the prosecutor was allowed to prove the defendants' unlawful drug possession, the defendants' good character evidence, even if admissible, was irrelevant to any issue in the case. The defendants were properly precluded from presenting evidence of their good character during the cross-examination of the state's witnesses. Some evidence of a defendant's reputation for truth and veracity may be introduced to help the jury evaluate the credibility of a witness, especially when the truthfulness of the witness is in issue. *Collins v. State*, 57 Md. App. 449, 463, 470 A.2d 757
