Where to file the petition Generally, cases involving alleged domestic violence are heard in municipal or superior courts. The Washington State Superior Court website contains a link to a table of offenses falling under the jurisdiction of each county. Burglary, domestic violence and stalking are offenses that will automatically be filed under Washington's domestic violence laws. An example of an offense that falls outside the domestic violence laws is one involving a family member's child who is beaten up, for example. Domestic violence offenses involving children are handled in Spokane County Juvenile Court, while assault, felony harassment and assault with a deadly weapon offenses can be filed in King County Superior Court. Additionally, juvenile courts can issue a temporary order for protection for a period up to six months and issue an emergency protective order for immediate protection. The Washington State's domestic violence prosecutor and the Spokane County Prosecutor can also issue a temporary or emergency order. Restraining orders are also issued by courts, on an ex-parte basis, allowing a judge to issue an order without giving the defendant a chance to respond. The goal of an ex-parte restraining order is to protect victims who fear immediate harm from their alleged abuser, but due process must be followed and the defendant must be given an opportunity to fight the restraining order.
